

The question of replacing the scale of Rs.1400-2300 with Rs.1400-2600 in respect of Librarians, raised by the Staff Side in the JCM/DC forum, has been engaging the attention of this Ministry for some time past. In consultation with the Ministry of Finance and Department of Education, it has now been decided that the scale of pay Rs.1400-2300 in respect of Librarians working in Railway Secondary or Senior Secondary Schools (and not in middle or primary schools) may be replaced with the scale of Rs.1400-2600 w.e.f. 1.12.1987. Pay will be fixed under the provisions of Rule 1313(I) (a) (2) -R.II, 1987 edition.

2. This has the sanction of the President and issues with the concurrence of the Finance Directorate of the Ministry of Railways.


