
Sub: Revision of pay scales (Senior and Selection Scales) for Primary School Teachers in Railway Schools.

In continuation of Board's above cited letter it has now been decided that the Senior and Selection Grade scales of Primary School Teachers in the Railway Schools be revised as under w.e.f. 01.01.1996:

	Existing	Revised
Basic Grade	Rs.4500-7000	Rs. 4500-7000(no change)
Senior Grade	Rs.5000-8000	Rs. 5500-9000.
Selection Grade	Rs.5500-9000	Rs. 6500-10500.

2. These scales of pay are also applicable to Junior School teachers of Oak Grove School, Jharapani under Northern Railway.
