Sub:- Passes/P.T.Os to staff of the Railway Audit Deptt.

With reference to the instructions contained in their letter of even number dated 14.4.60, the Railway Board desire to clarify that in addition to the privilege passes/P.T.Os admissible under the Pass Rules, the officers and staff of the Railway Audit Department including officers of the I.A. & A.S. serving in the Railway Audit Department may also be issued passes of the following nature to the extent and under the conditions governing the issue of such passes to Railway employees:-

(i) School passes;

P.T.O.

(ii) Transfer Passes:

(iii) Free residential Card Passes/Concessional Season Ticket over sections on which admissible;

(iv) Pass for transport of car;

(v) Settlement Passes;

(vi) Post-retirement complimentary Passes (except officers of the IA & AS, in respect of whom each case will be dealt with on merits);

(vii) Miscellaneous Passes over the home-line only as admissible to railway employees under the Home Line Pass Rules.

The Railway Board desire to further clarify that the Railway Audit staff shall not be entitled to the following concessions which are admissible to Railway servants only:-

(i) Passes on first appointment.

(ii) Passes to office-bearers of Unions of staff of the Railway Audit Department.

Board's instructions on the question of grant of:-

(i) Passes to receive settlement dues, and -

(ii) Passes on sports account, to the Railway Audit staff will be communicated to you shortly. Till then, passes under these two heads may not be issued to the Audit Staff.
