Please refer to your Railway's letter No. HPB/CS/ 4225/EL/BSL/DA No. 894/94 dated 18.9.95 on the subject cited above.

While delivering judgement on 3.4.1995 in the above mentioned case, the Hon'ble Supreme Court has held that "in view of the meagre amount involved, we do not consider it a fit case for examination of the question raised in the SLP". Thus the points raised by in SLP filed against the judgement delivered by CAT/Bombay in OA No. 894/94 have not been examined by the Supreme Court. Since this is a judgement in 'personam' and not in 'rem', it cannot be concluded that the Supervisory list circulated in 1962 by this Ministry has been held as invalid.

Ministry of Railways, therefore, desire that if any case arises in regard to the status of a category as Supervisory, it may be defended on the basis of the Supervisory list, circulated under Board's letter No. E(S)I 58-Adj/9 dated 22.9.62. A copy of a note jointly signed by the Deputy CLC(C) and Dy. Director, Estt. (Railway Board), wherein it was decided that the agreed supervisory list may be issued by the Government to Railway Administration and RLCs(C), is sent herewith. A copy of a D.O. letter No. 13/12/83-L5-II dated 16.2.1985 from Dy. Chief Labour Commissioner(C), New Delhi to Joint Director Establishment, Railway Board, indicating that the list issued in 1962 had the approval of the Department of Labour, is also enclosed. Both these documents may be made used of to Vindicate Railway's stand, whenever required.
