Reference Railway Board's letter of even number dated
15th/17th September, 1964, wherein instructions had been issued
for dealing with the cases of Railway servants who had suffered
loss of seniority and pay on account of administrative errors.
It has been suggested to the Board that the aforesaid orders may
be given retrospective effect to cover past cases. The Board have
considered the matter and it is clarified that these orders are
only applicable to those cases in which the seniority lost due
to an administrative error was detected and restored after
17.9.64 and not to those which were detected and finalised prior
to 17.9.64.
