Some doubts raised about the intention of these orders have been clarified as follows: - paragraphic and the state of t

- (1) Mistries should also be included in the field of selection along with HSK I & II.
- (2) The restriction in Board's letter of 30.10.74 does not apply to selection of Intermediate Apprentices from artisans (skilled grade and above) who fulfil certain qualifications against the 20% quota.

It has been represented by some Railways that still difficulty is being experienced because in the Carriage & Wagon Department posts of Highly Skilled Artisans Gr.I and II are not available in some categories. Even in categories where there are such posts difficulty is being experienced because no suitable persons are available for promotion most of the staff being illiterate.

The Board have examined the matter and decided that the following procedure should be adopted for filling the promotion quota of 40% of vacancies of TXRs & 425-700 (RS):

- (i) The available Highly Skilled Gr.I and Gr.II staff and Mistries should first be subjected to selection without imposing any additional restriction about educational qualifications. As in the case of all selections the field of eligibility should be 3 times the number of vacancies. If the selection does not result in empanelment of the necessary number, a supplementary selection may be held to which the remaining staff, beyond 3 times the number indicated above, in the HSK Gr.I and II and Mistries, may be called.
- (ii) If the above does not result in empanelment of the required number, another supplementary

selection may be held where Skilled staff in the Dalli, deted as-lawiff Carriage & Wagon Department who-

- (a) have 5 years of service in the Skilled grade with 8th Standard qualifications, or
- (b) have 3 years service in Skilled grade with Matriculation,

may be called for selection. A combined list of (a) and (b) will be arranged in the order of seniority and the orders about restricting the number to three and the vacancies apply to this supplementary selection. For example, if there are 20 vacancies in the promotion quota and 10 hSk I and II/Mistries have already qualified in the selection, the Skilled at a first to be accorded will be limited to 10 x 3 staff to be considered will be limited to 10 x 3 viz. 30 and the first 30 in the combined seniority list of (a) and (b) above will be called for selection.
