Subject :- Filling up the posts in Safety
Categories - Relaxation of
service experience of 2 years
in the lower grade in case of
Intermediate Apprentices etc.

At present a certain percentage of posts in the
scale of Rs. 425-700 in Mechanical etc. disciplines is
filled from Intermediate Apprentices i.e. from amongst
serving employees having requisite qualifications such
as Diploma etc. in the discipline concerned. These Staff
are further given training to make them fit for the post
to which they are promoted. Since such staff have all the
attributes of a direct recruit and given training also
to make them fit for the job, Ministry of Railways
have decided that the service condition of 2 years in
the lower grade as stipulated in Ministry of Railways

letter NO. E(NG)I/75/PMI/44 dated 31-5-1982 and 21-9-1982 may not be insisted in such case.

This also disposes of Southern Railways's letter NO. P(S)/608/IX/DM dated 2/3/1983.
