Sub:-Guidelines for Personnel Officers and Members of Selection Boards constituted for conducting selection for promotion to the posts classified as "Selection".

As the Railways are aware in terms of para 219(b) of IREM Vol. I (1989 Edition), an officer of the concerned Department who is also a member of the Selection Board should set the question paper for written examination. Where possible another officer of the concerned department who is also a member of the selection Board should be nominated to evaluate the answer books, ensuring, however, that the answer books are invariably evaluated by a Member-Officer belonging to the department for which selection is held. This provision has been reiterated in Para 3.5 of the Guidelines for Personnel Officers and Members of Selection Boards constituted for conducting selection for promotion to the posts classified as 'Selection' as circulated under Board's letter No.E(NG)I-98/PM1/17 dt.20.10.99, Para 3.5 of these guidelines also contain an explanatory note that as far as possible the officers nominated to set the question paper and evaluate the answer books should be different and where this is not possible there is no objection to the same officer setting the question paper and evaluating the answer books ensuring that the officer nominated to set the question paper and to evaluate the answer sheets should belong to the department for which the selection is held.

2. The Staff Side in the forum of DC-JCM have represented against the provision of allowing the same Member-officer to set the question paper and evaluate the answer books. In this connection the Board wish to have the information regarding the total number of selections with written tests conducted by the Railways/PUs during the last two calendar years, Division-wise/Unit-wise, as per the prescribed proforma enclosed.

3. The required information may be sent so as to reach this Ministry by 14.08.2006 positively.
