Rs.4000-6000- consideration of Group 'D' staff.**

2. The matter has been examined. The issue of considering shorthand knowing Gr. 'D' staff for appearing in the selection for promotion to the post of Stenographer Gr. III was considered by the Board earlier but not agreed to. However, Group 'D' staff fulfilling the qualifications prescribed for direct recruitment are eligible to appear in the GDCE which the S. E. C. Railway must be implementing since DR quota to the extent of 50% exists in the category and, shortfall, against promotion quota is also required to be added to direct recruitment quota. For speedy filling up of vacancies, concerned RRB may be requested to furnish a panel separately for GDCE in respect of the category of Stenographers.

3. Incidentally, in SEC Railway's letter under reference no mention has been made of the fact that besides Shorthand knowing Clerks, Shorthand knowing Typists are also eligible to appear in the selection against 25% quota vide Board's letter No.E(NG)II-98/RR-1/14 dt.16.03.99. ✓
