UPG/3 dated 1.5.84 on the above subject.

2. As the Railway Administrations etc. are aware "a one time relaxation" was granted in this Ministry's letter of even number dated 7.10.1983 in regard to the requirement of a minimum of two years regular service in the relevant lower grade for promotion to posts in safety categories against the vacancies arising as a result of restructuring ordered in this Ministry's letter dated 29.7.1983. This relaxation was subject to certain conditions as stated in the letter of 7.10.1983. A similar relaxation was allowed in this Ministry's letter of even number dated 3.5.84 in respect of safety categories restructured in this Ministry's letter of 20.12.83.
3. It has now been decided as a special case that the instructions contained in this Ministry's letter of even number dated 7.10.83 will also apply mutatis-mutandis to promotions to safety categories against vacancies covered by the restructuring orders contained in the Ministry's letter No.PCIII/83/UPG/3 dated 1.5.84. Particular attention is invited to para 3.1 of the letter of 7.10.1983 whereby a competency certificate is necessary in cases in which the condition of two years service including ad hoc service is not satisfied.
4. The Ministry of Railways would like to reiterate that this special dispensation is being accorded as "one time exception" with a view to facilitating expeditious implementation of the restructuring orders in question. It will thus not be applicable to vacancies arising in the normal course after restructuring. In other words in respect of vacancies arising after 1.1.84 in the categories in question the extant orders contained in this Ministry's letter No.E(NG)I/75/PMI/44 dated 31.5.1982 as amended/clarified from time to time will
