Sub: Circulation of list of office bearers of ad-hoc Executive  
Committee of All India SC/ST Railway Employees Association  
at all levels.

One of the Zonal Railways viz. North Eastern Railway have sought Board's clarification regarding circulation of list of office bearers of ad-hoc Zonal Executive Committee of All India SC/ST Railway Employees Association so as to deal with the conflicting situation in the matter.

It has been experienced by the Board that circulation of list of ad-hoc Committee of such Association is a matter of conflict since long. Literally the object of functioning of ad-hoc body is just to facilitate fresh election of the Executive Committee of the Association at all level on expiry of its tenure so as to form regular body through a democratic process of election as per bye-laws of the Association. But, there is a tendency that such ad-hoc bodies keeps continuing months after months, years after years defeating the very purpose of formation of ad-hoc bodies which is perhaps creating lots of problem amongst the office bearers and the rival groups leading to number of court cases/conflicts etc.

Board after careful consideration desire that tenure of such ad-hoc bodies of the Association should not exceed four(4) months from its formation by which they have to conduct the fresh election and place a regular elected body so as to run the Association smoothly for the common cause of the Association i.e. welfare of the SC/ST Railway employees. If regular body is not formed within the stipulated period of '4 months', the facilities being enjoyed by the office bearers of the Association would stand withdrawn with immediate effect. Similarly, the ad-hoc bodies which are already functioning on the Railways at all levels may also be advised to conduct fresh elections immediately within the period of 4 months so as to place a regular body.
