Reference Adviser(S), Railway Board's d.o. letters NO E(W) 89WE6-2 dated 15-3-89 and 25-5-89 inter-alia laying down guidelines for holding Inter-Railway Cultural Competitions.

2. The question of financing the annual Inter-Railway Cultural Competitions has been considered by the Board. It has been decided that the Inter-Railway Cultural Competition should be financed from the Staff Benefit Fund. For this purpose, from out of the Head "Recreation Other than Sports" for which an amount of Rs.2 per capita has been earmarked vide para 3(b) of Ministry of Railways letter NO.E(W)86FU1-1 dated 14-5-87, a per capita contribution of 5 P. (paise five only) will be earmarked for being spent on Inter-Railway Cultural Competitions every year. Allotment of this part of the Fund to the various organising railways as may be decided by the Board, will be made centrally by the Board.

3. These orders will be effective from 1-4-1990.

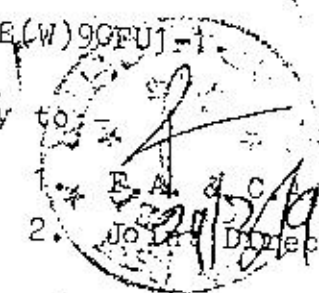
