Sub: Circulation of Provisional Seniority List of Group 'B' officers of Cash & Pay Department – Appointment to the posts of Chief Cashier in Group 'A'/Sr. Scale.

For making appointments in Group 'A'/Sr. Scale from Group 'B' in the Cash & Pay Cadre of Indian Railways against the available vacancies through DPCs convened by the UPSC, the seniority of Group 'B' officers in the Cash & Pay Department of various Railways/PUs as on 01.01.2014 has been integrated on All India basis in terms of the following principles and is enclosed:-

- i) In the order of Group 'B' dates of the officers, but without disturbing the prevailing inter-se seniority on each Railway Zone/Production Unit.
- ii) For those who have joined the Railways on transfer from other Railways on bottom seniority basis, the dates on which the orders for such transfers are issued by the Railway Board or the actual date on which such officers join the Railways on bottom seniority basis, as the case may be, will be treated as their Group 'B' date for the purpose of integrating the Group 'B' seniority on All India basis.
- iii) When Group 'B' dates happen to be the same, officers with earlier date of birth will rank senior to those with later date of birth.

2. The enclosed seniority list needs to be circulated immediately inviting representations, if any, from the Group 'B' officers, within 15 days positively from the date of circulation, but before that the Railways/PUs concerned are advised to cross-check the entries in Columns (2) to (6) from the official records in order to verify the correctness of the same and if there is any discrepancy, it should be brought to the notice of this office immediately. If any Group 'B' officer has joined any Railway/PU on bottom seniority, the entry in column (6) should reflect the date of Board's order effecting such transfer or the actual date on which the officer joined the Railway, as the case may be, and in that case the officer concerned will have to be assigned appropriate seniority in Group 'B' in terms of the principle mentioned at 1(ii) above. If any of the officers of the enclosed list has ceased to be in service (other than by

superannuation), the same may be brought to the notice of this office immediately. Of late, some reviews have become necessary for the sole reason that information placed before the DPC w.r.t. category, Group 'B' date, etc. of the officers was incorrect, for which the UPSC has taken a very serious view. Therefore, utmost care needs to be taken to finalize the integrated Group 'B' seniority. For any incorrect information, the Railways will be solely responsible.

3. As and when representation(s) are received, the same may be forwarded to the undersigned with comments w.r.t. the contention made and its correctness as per official records. Any representation forwarded without comments will not be entertained and the onus in that event will lie on the concerned Railways. If no representation(s) are received within the stipulated period, the seniority list so circulated shall be treated as final. In any case, if no representation(s) are received within 30 (thirty) days from the date of issue of this letter, it shall be presumed that no representation(s) have been preferred and the seniority list shall be treated as final.

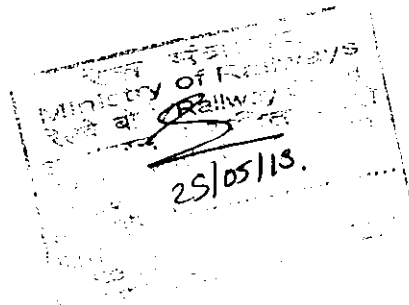
