

2) The issue has been considered by the Board and it has now been decided that Non-Vigilance administrative cases also qualify for the same remuneration as applicable to the Vigilance cases as issued vide Board's letter No. 2009/V-1/DAR/6/1 Dt. 22.9.2011.

2.1) The rates of honorarium for various posts as and when enhanced by Vigilance Directorate, will automatically be applicable to those conducting Non Vigilance cases.

3) The rates of Non-Vigilance cases will be applicable from the date of issue of the letter.

4) This issues with the concurrence of the Finance Directorate of the Ministry of Railways.


