Subject:- Regularisation of allotment of Railway quarters in
the name of eligible dependent of Railway employee
who retires from or dies while in service.

Reference Railway Ministry's letter No. E(G)85 QR1-9 dated
15.1.1990 on the above noted subject.

Certain clarifications in regard to the above instructions
have been sought for by various Railways. The same are clarified
as under:-

<u>Point raised</u>	<u>Clarification</u>
(i) Whether the intention is not to allow out of turn allotment to the eligible dependents appointed on compassionate grounds in the event of medical invalidation of their parent and consequent retirement from service?	Out of turn allotment of residential accommodation may be made to the eligible dependent provided other conditions of such ad hoc allotment are fulfilled.

- (ii) whether time factor of 12 months still exists? Yes.
- (iii) whether mother of the deceased railway employee is not entitled for out of turn allotment? Mother is eligible for allotment of quarter on out of turn basis, if appointed on compassionate grounds.
- (iv) whether a ward of a Railway employee, who also happens to be in Railway service, is entitled for out of turn allotment, in the event of voluntary retirement by his parent? Cases of compassionate appointment of persons who seek voluntary retirement are to be dealt with as per normal retirement rules.
- (v) whether casual labour/ substitutes with or without temporary status are still not entitled to such benefits? Reply is in affirmative.
- (vi) The term 'Cancellation' used is not clear. The term 'Cancellation' under note (vi) of para 3 of Railway Ministry's letter referred to above means the date from which the allotment should be treated as cancelled. Such a date shall be the date on which the four months' period on normal rent expires. This is, however, subject to the proviso that where the same accommodation is to be regularised in the name of the eligible dependent, the date of cancellation shall be the date of retirement/death.
