Sub: Amendment to IREC/Vol.I (1985 Edition) - Rules 923 and 925 permitting advance/final withdrawal separately for betrothal ceremony and marriage.

In terms of Board's letter No. F(E)III/67/PF1/18 dt. 24.2.68 advance/final withdrawal is permitted separately for both betrothal and marriage provided the total amount of such advance/final withdrawal does not exceed the ceiling limit prescribed for marriage under the SRPF Rules. It has now been decided that advance/final withdrawal may be permitted both on the occasions of the betrothal ceremony and marriage ceremony, treating each occasion as a separate purpose.
