Sub: Revision of pension of Pre-1986 retirees where records are not available.

Clarification has been sought by some of the Zonal Railways in regard to revision of pension in old cases where records are not at all available either with the individual concerned or personnel/accounts departments for verifying the last pay drawn, pay scale held at the time of retirement and the qualifying service required for revision of pension especially in the case of pre-1986 retirees. It is clarified in this context that in all such cases where inspite of best efforts, it is not possible to revise the pay on notional basis due to non-availability of service records, pension consolidated as on 1.1.1996 in terms of DOP&PW's OM dt. 27.10.97 circulated vide Board's letter No.F(E)III/97/PN1/23 dt. 7.11.97 may be treated as final. However, in all such cases, family pension as on 1.1.1996 will have to be revised to 30% of the minimum pay in the Vth CPC scales of pay introduced w.e.f. 1.1.1996 corresponding to the scale of pay last held by the retired/deceased Railway servant as stipulated in instructions issued by DOP&PW vide their 0.M. dt. 27.7.99 and circulated on the Railways vide Board's letter No. F(E)III/98/PN1/29 dt. 15.10.99.

- 2. Subsequently, however, if the records are traced out, the pension in respect of such pre1986 retirees may be calculated on the basis of DOP&PW's OM dt. 10.2.98 circulated vide
 Board's letter No. F(E)III/98/PN1/2 dt. 10.3.98 and para 4.1 of Board's letter No.
 F(E)III/98/PN1/29 dt. 15.1.99 and the final pension sanction may be issued. In case the amount
 of final pension happens to be less than the pension consolidated in terms of DOP&PW's OM dt.
 27.10.97, it should not be revised to the disadvantage of the pensioner as reiterated in
 DOP&PW's OM No. 45/86/97-P&PW(A) part-III dt. 24.7.98 circulated vide Board's letter No.
 F(E)III/98/PN1/2 dt. 2.9.98.
- 3. The pension sanctioning authorities may revise the pension of all Pre-1986 pensioners with the approval of the Head of Office in terms of the above instructions if applications have already been received for the same.
