Accordingly, any Railway servant, who was not a pension optee at the time of his permanent absorption in Public Sector Undertakings etc., would not be covered under the provisions of the orders dated 7.4.95. The corrigendum issued vide Board's letter of even number dated 25.6.97 may, therefore, be treated as withdrawn.
