Sub: SLP filed in the Supreme court against the judgement dtd. 18.5.2002 of the Delhi High Court in W.P. Nos 7322, 7826 and 7878 of 2001.

Consequent upon setting aside the instructions contained in Department of Pension and Pensioners' Welfare's OM.No. 45/3/99 P&PW (A) dated 29.10.99, adopted on the of Delhi in Writ Petitions Nos. 7322, 7826 and 7878 of 2001 filed by the Retired Railway Medical Officers 'Association and Others, the Department of Pension and Pensioners' Welfare have filed SLP bearing Nos. 8991-8993/2002 before the Hon'ble Supreme Court on behalf of Ministry of Railways and others. The SLP has been admitted by the Hon'ble Supreme Court on 2.12.2002. The matter is yet to come up for regular hearing. Zonal Railway administrations are requested to bring this to the notice of the CATs/High Courts through their counsels, while the OAs and Writ Petitions filed by the Retired Railway Medical Officers for addition of NPA to the notional pay as on 1.1.1986 and/or to the minimum of the revised scales of Pay introduced w.e.f. 1.1.1996 come up for hearing. Further progress of the SLP pending with Hon'ble Supreme Court will be advised in due course.

This also disposes of the Central Railway's letter No. HPB/581/G/Court/190 dated 6.1.2003.
