The undersigned is directed to refer to this Department's OM of even number dated 2.04.2002 extending the date of submission of applications for revision of pension/family pension of pre-1986 pension/family pensioners upto 31.12.2002. Representations have been received in this department for extending the date for submission of applications beyond 31.12.2002. The matter has been considered in this department and it has been decided to extend the date of submission of application for revision of pension/family pension in such cases upto 30.09.2003. However, Defence civilian pensioners will continue to be governed by orders issued by the Ministry of Defence.

Similarly it has also been decided to extend the date of submission of applications for revision of pension/family pension with reference to this department's OM no.(1) 45/86/97-P&PW(A)-Part IV dated 08.05.1998 read with OM dated 30.11.1998 and dated 17.12.1998 for submission of applications by the pensioners covered under these OM upto 30.09.2003.
