
**Sub: Payment of extraordinary family pension to dependent parents,
brothers, sisters etc. – Clarification regarding.**

In terms of para 3.I (1) & (2) of DOP&PW's O.M. No. 45/22/97-P&PW (C) dated 3rd February, 2000 circulated vide Board's letter No. F(E)III/2000/PN1/16 dt. 8.3.2000, the quantum of monthly extra-ordinary family pension for widows, children, including fatherless/motherless children covered under categories B & C shall be 40% of basic pay subject to a minimum of Rs. 1650/- in the case of deceased non-pensionable Government servants and 60% of basic pay subject to a minimum of Rs. 2500/- in the case of deceased pensionable Government servants. Further, dependent parents, brothers, sisters etc., shall be paid family pension at one-half the rate applicable to widows/fatherless or motherless children i.e. 20% and 30% of the basic pay in case of deceased non-pensionable and deceased pensionable Government servants, respectively. In terms of these instructions, if the minimum family pension admissible to widows is halved for the purpose of sanction of family pension to dependent parents, brothers, sisters etc., it would amount to Rs. 825/- and Rs. 1250/- in the case of deceased non-pensionable and deceased pensionable Government servants, respectively, which is less than the minimum ordinary family pension i.e. Rs. 1275/- p.m. admissible w.e.f. 1.1.1996.

2. The matter has been examined in consultation with the Department of Pension & Pensioners' Welfare (DOP&PW) and Department of Expenditure and it is clarified that if the amount of family pension to dependent parents, brothers, sisters, etc., of the deceased non-pensionable and deceased pensionable Railway servants worked out as per para 3. I (2) of DOP&PW's O.M. dt. 3.2.2000 falls below Rs. 1275/-, the same may be stepped up to Rs. 1275/-.



विषय : आश्रित माता-पिता, भाइयों, बहनों आदि को असाधारण पारिवारिक पेंशन के भुगतान के संबंध में स्पष्टीकरण.

बोर्ड के 8.3.2000 के पत्र सं. एफ (ई) III/2000/पी एन1/16 के द्वारा परिपत्रित पेंशन एवं पेंशनर कल्याण विभाग के 3 फरवरी 2000 के का.ज्ञा.सं. 45/22/97-पी एंड पी डब्ल्यू (सी) के पैरा 3.I (1) एवं (2) के अनुसार, ख और ग कोटियों में शामिल बिना माता/पिता के बच्चों तथा विधवाओं के लिए मासिक असाधारण पारिवारिक पेंशन की राशि गैर-पेंशनी दिवंगत सरकारी कर्मचारी के मामले में मूल वेतन का 40% होगी जो न्यूनतम 1650/-रु. होगी और पेंशनी दिवंगत सरकारी कर्मचारियों के मामले में मूल वेतन का 60% होगी जो न्यूनतम 2500/-रु. होगी. साथ ही, आश्रित माता-पिता, भाइयों, बहनों आदि को विधवाओं/बिना माता/पिता के बच्चों के लिए लागू दरों की आधी दरों पर अर्थात् गैर-पेंशनी दिवंगत कर्मचारी तथा पेंशनी दिवंगत सरकारी कर्मचारियों के मामले में मूल वेतन के क्रमशः 20% तथा 30% पर पारिवारिक पेंशन का भुगतान भी किया जाएगा. इन अनुदेशों के अनुसार, यदि आश्रित माता-पिता, बहन-भाइयों आदि को पारिवारिक पेंशन की मंजूरी के प्रयोजन के लिए विधवाओं को स्वीकार्य न्यूनतम पारिवारिक पेंशन का आधा किया जाता है तो गैर-पेंशनी दिवंगत सरकारी कर्मचारी तथा पेंशनी दिवंगत सरकारी कर्मचारियों के मामले में यह राशि क्रमशः 825/-रु. और 1250/-रु. होगी जो न्यूनतम साधारण पारिवारिक पेंशन अर्थात् 1.1.1996 से स्वीकार्य 1275/-रु. से कम है.

2. पेंशन एवं पेंशनर कल्याण विभाग तथा व्यय विभाग के परामर्श से इस मामले की जांच की गई है और यह स्पष्ट किया जाता है कि यदि गैर-पेंशनी दिवंगत रेल कर्मचारियों तथा पेंशनी दिवंगत रेल कर्मचारियों के आश्रित माता-पिता, बहनों, भाइयों आदि को पारिवारिक पेंशन की राशि का हिसाब पेंशन एवं पेंशनर कल्याण विभाग के 3.2.2000 के कार्यालय ज्ञापन के पैरा 3.I (2) के अनुसार लगाया जाता है और यदि वह 1275/-रु. से कम रहता है तो उसे 1275/-रु. तक बढ़ा दिया जाए.

The undersigned is directed to Ministry of Railways' OM No. F(E)III/2003/PN1/27 dated 18.7.2003 on the above subject. The matter has been examined in this Department in consultation with the Department of Expenditure.

2. It is clarified that the amount of family pension when worked out as per para 3 (1) (2) of this Department's OM dated 3.2.2000 and if it falls below Rs. 1275/-, may be stepped up to Rs. 1275/- in the case of family pension payable to dependent parents, brothers, sisters etc.
