Instructions were issued vide Board's letter No. PC-V/98/1/11/23 dt. 7.3.2003 for grant of higher pay scales to Railway Accounts Staff on notional basis w.e.f. 1.1.1996 and actual payment prospectively from 19.2.2003. Subsequently, instructions on revision of pension of the Accounts staff, who retired during the period 1.1.1996 - 18.2.2003, were also issued vide Board's letter of even number dt. 16.6.2004. The National Federation of Indian Railwaymen has now sought clarification as regards the pay for the pre-19.2.2003 period, to be taken into account for determining the average emoluments in respect of the Accounts Staff covered by the instructions of Board dt. 7.3.2003 and retired on or after 19.2.2003
