STATE RAILWAY PROVIDENT FUND RULES

ADVANCE CORRECTION SLIP NO. 94

Rule 925 (3) (b) (i)

Replace clause (b) (i) of sub-rule (3) of Rule 925 by the following:-

Six months pay in the case of betrothal/marriage of subscriber or # (i) his/her son or daughter, or any other female actually dependent on him/her,"

Rule 925 (3) (b) Note 2.

Replace Note 2 below clause (b) of sub-rule (3) of Rule 925 by the following:-

"Note 2.- In special cases, the sanctioning authority may relax the limit at (i) above for marriage of subscriber's daughter keeping in view the status of the subscriber and the amount standing to his/her credit in the Fund, but in no case should more than 15 months' pay be sanctioned."

Rule 925 (4)

Insert the following as clause (c) below clause (b) of sub-rule (4) of Rule 925 and the existing clause (c) may be renumbered as clause (d):-

"(c) In special cases, keeping in view the course of study, status of the subscriber and the amount standing to his/her credit in the Fund, the sanctioning authority may relax the limit of three months pay or half the amount standing to the credit of the subscriber in the Fund, whichever is less, as laid down in proviso to Rule 923, but in no case should more than three fourths of the amount standing to the credit of the subscriber in the Fund be sanctioned."

Rule 925 (5)

Insert the following as clause (b) below clause (a) of sub-rule (5) of Rule 925 and the existing clauses (b) & (c) may be renumbered as clause (c) & (d):-

"(b) In special cases, keeping in view the type of illness, status of the subscriber and the amount standing to his/her credit, the sanctioning authority may relax the limit laid down in proviso to Rule 923, but in no case should more than three-fourths of the amount standing to the credit (Authority : Ministry of Railway's letter No. F(E)III/2005/PF1/2 dated

2.11.2005)
