Attention is invited to para 2.C of Annexure to  
Board's letter of even number dated 24.4.98 wherein  
the entitlements for travel on tour by various means  
of transport by road have been prescribed.

2. Clarification have been sought by Railways  
regarding the entitlements for journeys by ordinary  
taxi.

3. It is hereby clarified that officers drawing basic  
pay of Rs.6500/- or above in the revised scales of pay are  
entitled to travel by taxi in respect of journeys  
performed to an outstation on duty (tour, transfer, etc.).

4. As regards journeys performed locally within the city/  
urban agglomeration/contiguous locality, in which the  
headquarters of a Railway servant is situated, the Railway  
employees will continue to be governed by the orders contained  
in Board's letter No. F(E)I/87/AL-7/2 dt. 28.8.87 (i.e.  
officers drawing pay of Rs.3200/- or above in the pre-revised  
scales of pay RS(RP), Rules, 1986 will be entitled to travel  
by taxi until further orders).

5. Accordingly, in exercise of the powers conferred by  
the proviso to Article 309 of the Constitution, the President  
is pleased to direct that the Advance Correction Slip No.31  
to Indian Railway Establishment Code Vol.II (First  
Re-print), 1990 issued vide Board's letter No.F(E)I/98/  
AL-28/17 dated 27.11.98, shall be modified partially as  
per the Annexure enclosed.

Rule 1607 - Sub Rule (5)

Please substitute the following in lieu of  
existing entitlements for item (i) i.e. pay range  
of Rs. 18400/- and above in the table in ACS No. 31  
revising the Rule-1607(5).

<u>Pay Range</u>	<u>Entitlements</u>
(i) Rs.18,400 and above	Actual Fare by any type of public bus including Air-conditioned bus; OR At prescribed rates for AC taxi when the journey is actually performed by AC taxi OR At prescribed rates for Ordinary Taxi when the journey is actually performed by Ordinary Taxi/Own Car OR At prescribed rates for autorickshaw for journeys by autorickshaw, own scooter/motorcycle, moped etc.
