Sub: Delegation of Powers to permit Air Travel in connection with the officers posted on USBRL Project.



In terms of Board's letter of even number dated 13.09.2018, regarding delegation of powers to permit Air Travel in connection with Udhampur-Srinagar-Baramulla Rail Link (USBRL) Project, the power to permit Air Travel on duty on Delhi-Jammu-Srinagar-Delhi circuit for officers of all Grades (JS, SS, JAG, SAG and above) posted in USBRL Project was delegated to CAO/C/USBRL for officers under his administrative control as a special case for a period upto 30.09.2019.

It has now been decided with the approval of Board (FC) that the above mentioned delegation of power to CAO/C/USBRL may be extended for a period of one year beyond 30.09.2019 i.e. upto 30.09.2020.


