Sub: Delegation of powers to permit Air travel in connection with Final Location Survey of Bilaspur-Manali-Leh, new BG Railway line.

Ref: Northern Railway's letter No.176-W/Survey & Construction/TKJ, dt. 08/05/18.

In terms of Board's letter No. F(X)II/2015/PW/7, dt. 12.06.2017 followed by letter No. 2017/Trans/01/Policy, dated 18.10.2017, powers had been delegated to GM to permit air travel on duty to officers not below Junior Scale level subject to certain terms and conditions.

The proposal regarding delegation of powers to permit Air travel for officers (SAG & below) and Supervisors connected with FLS of Bilaspur-Manali-Leh, new BG Railway line to CAO/C-II has been examined in Board's office and it has been decided with the approval of Board (FC) that:

- (i) The power to permit Air Travel in connection with Final Location Survey of Bilaspur-Manali-Leh, new BG Railway line may now be delegated to CAO/C-II/NR as a special case for a period up to 31/03/2019, after which, if needed to continue, same may be considered on annual basis.
- (ii) This will be subject to the ceiling limit of allotted budget for Air Travel.
- (iii) This delegation of power will be limited to Delhi(DEL) to Leh(IXL)/ Bhuntar(KUU)/ Srinagar (SXR) and return section only.
- (iv) This will also be subject to the other Terms & Conditions/instructions issued from time to time by Board's office on 'Air Travel'.
