

Sub: Delegation of powers to General Managers – regarding Air Travel.

Ref: Board's letter No. F(X)II/2014/PW/6 dated 11/12/2014.

In terms of Board's letter No. F(X)II/2014/PW/6 dt. 11.12.2014 powers had been delegated to GM (Con.)/N.F. Railway to permit officers of Sr. Scale (GP Rs. 6600/-) & Jr. Scale (GP Rs. 5400/-) working in National Projects in N.F. Railway to travel by air on duty from Silchar, Imphal, Agartala, Aizwal to Guwahati & back and between Dibrugarh & Lucknow. These powers were to be exercised with personal concurrence of FA&CAO(Con.) and personal approval of GM(Con.) and were applicable for a period of one year when they were to be reviewed. These powers were subject to other conditions indicated in Note-A to Item 22 of SOP to GMs.

The matter has been reviewed by Board and in view of the large number of projects of construction of new lines being executed in N.F. Railway, and taking into account the continuing difficult and special conditions prevailing in N.E. Region, this delegation of powers to GM(Con.)/N.F. Railway has been extended for three years i.e. upto 10.12.2018, after which it will be reviewed.






