**Sub: - Workshop/Training Programmes for Training of Trainers- Request for sending nominations and suggesting schedule.**

A training programme is planned in collaboration with FSSAI for master trainer who will be further utilized in their respective zones as Master Trainer for FBOs etc.

Training of Master Trainers of NR, NCR, NER, NWR, SECR & WCR regarding the Project -Safe food on track initiated by FSSAI in collaboration with Indian Railways and IRCTC had already been organized for Delhi region at Delhi on 06-07 July 2017.

Now it is proposed to organize a similar workshop/training programme at Kolkata and Mumbai region by FSSAI. The different zones of Indian Railways except NR, NCR, NER, NWR, SECR & WCR are advised to send their JFSC DO and FSOs not more than four in numbers and not less than two in numbers. The center of training is as follows:-

1. Eastern Railway/Kolkata for ER, ECR, ECoR, NFR & SER.
2. Western Railway/Mumbai for CR, WR, SR, SCR, & SWR.

Joint Food Safety Commissioners (JFSCs) of the ER/Kolkata and WR/Mumbai will be the nodal officer for coordinating with FSSAI for the said training programme. It is advised that JFSCs/ER/WR may arrange all necessary steps for training programme, ~~stay along with~~ <sup>stay along of</sup> trainers and participants, other logistics and also arrange respective venue, date, and time for the said training programme and inform the FSSAI <sup>to</sup> arrange to send their trainers accordingly.

It is also advised that nodal officers of ER and WR to coordinate with other zones for nomination of the trainees and also directly coordinate with FSSAI for the programme. Name & mobile no. of the JFSCs/nodal officers of ER and WR is as under.
