


To implement Ayushman Bharat Pradhan Mantri-Jan Arogya Yojana (AB PM-JAY) a Joint Procedure Order was issued vide letter dated 07.03.2019 to be followed by the concerned Railways in identified Railway Hospitals coming under their jurisdiction. In S. No. 3, 4, 10, 11 & 12 under the 'Persons responsible' column in case of **Central Hospitals** the following may be added:-

S. No.	Actionable points	Persons responsible
3.	Appointment of Non medical coordinator in each hospital on outsourcing basis.	MD, Dy. FA & Dy.CPO should co-ordinate to initiate the proposal and to be approved by GM/AGM as the case may be.
4	Arrangement of requisite hardware and internet along with necessary accessories and stationery.	MD in co-ordination with concerned Dy. CSTE/Sr. CSTE as the case may be.
10	Raising of the bills for expenditure incurred for indoor treatment (as per package).	Medical coordinator (Railway Doctor) in co-ordination with non medical coordinator. Concurrence of bill by associate finance and approval of AGM/PCMD as the case may be.
11	Expenses made for treatment of Ayushman Bharat patient and money received for treatment to be booked in separate head.	MD and Dy. FA to ensure for the same. Accounts may be reconciled quarterly.
12	The responsibility of ensuring smooth rendering of the facility to the eligible beneficiary in the identified Railway hospital.	AGM/PCMD and MD in co-ordination with medical coordinator.
