**Sub: -System improvement regarding CME and CHA Funds.**

CVC has observed, "Even if the contribution to the CME fund and CHA fund is voluntary, these should not be allowed to be maintained by Government officers in official manner unless there clear policy guidelines issued by the Railway Board."

There have been instances where various funds in the name of carrying out medical educational activities/ Seminars/ Conferences/ Hospital Development are raised.

The Instructions contained in RBE No. 59/2010 (letter No. E(D&A)2009 GSI-6 dated 21.04.2010) are reiterated to be followed strictly.

Wherever such funds have been used in contravention these should be regularized by postfacto sanction of Competent Authority.

Wherever such funds exist in contravention to above mentioned policy guidelines, they should be closed immediately and balance money in the account as well as FDs, if any, should be utilized in consultation with Associate Finance and with the approval of Competent Authority of the Zone/PU/RDSO.

It should be ensured that these instructions are available with all doctors.
