
Sub:-List of registered firms and their product list for supply of drugs/pharmaceutical products over Indian Railways.

Ref:- This office letter of even number dated 20.12.2018, 04.01.2019 and subsequent amendments issued thereafter.

Subsequent to the issuance of Drug Procurement Policy, 2014, an exercise was undertaken to verify the credentials of the then registered firms to ensure that only eligible firms as per revised Policy remain registered with the Railways. Accordingly a list of 95 firms with the available product list was issued to the Zones vide letter of even number dated 20.12.2018. Some more firms were added / product list revised vide letter dated 04.01.2019 and subsequent amendments issued thereafter. **Now the process of examination of documents of all the firms has been completed and as on date (13th September, 2019) 125 firms are found fulfilling the laid down criteria out of which 112 firms have deposited the Registration Fee of Rs.50,000/- and their product list are also available. In remaining 13 cases either the firms have not deposited the Registration Fee or their product list is not as per inspected manufacturing Units.**

Therefore, in suppression of all letter issued from 20.12.2018 and thereafter on the subject, a list of 125 firms having approval for continued registration is enclosed herewith which also contains their eligibility for number of products and whether the firm has submitted the Registration Fee of Rs.50,000/- or otherwise. Further, the product list of 112 firms included in the list that have deposited the Registration Fee and their products lists are as per inspected manufacturing units, has been uploaded on Railway Board Website. The list of Registered Firms and their product list can be viewed by visiting Health Directorate site on the Railway Board Website. These firms will remain registered till March, 2021 subject to adherence to the laid down instructions. Thereafter, the exercise of renewal of the eligible firms will be taken up. However, registration of new firms will continue to be done as usual and they will be added to this list from time to time.

The Zone/ PUs are advised to resort to procurement of Drug/ Pharmaceutical products only from the 112 firms who have deposited the registration fee and whose product list is uploaded on the website. However, if a Zone/ PU finds that certain drug/ pharmaceutical product required is not available in the list of firms/ product list uploaded on the website, they may resort to purchase from a firm/ product not included in the uploaded list, after recording the specific reasons(s) on their respective files.
