Sub : Retired Employees Liberalised health Scheme (RELHS-97)- clarification.

In partial modification of Board's letter No. 2003/H/28/1/RELHS dated 30.12.2005 on the above cited subject, it is advised that the existing para 2 of the letter may be amended as under:-

Existing

Railways may, therefore, act accordingly and permit such cases who intend to join RELHS-97 till 31.12.2005

Amended

- (a) All medically invalidated employees and the spouses of the employees who died in harness before 31.12.2005, may be permitted to join RELHS by 31.12.2005.
- (b) All medically invalidated employees and the spouses of the employees who die in harness, henceforth, will be permitted to join RELHS within 3 (three) months from the date of invalidation/death of the employee.

2 All other terms and condition as laid down in Board's letter referred to above will remain unaltered.



संशोधित
(क) सभी चिकित्सीय रूप से अशक्त कर्मचारियों और ऐसे कर्मचारियों के विवाहिता, जो 31.12.2005 से पहले कार्य के दौरान मारे गए हैं, को 31.12.2005 तक सेवानिवृत्त कर्मचारी उदारीकृत स्वास्थ्य योजना में शामिल होने की अनुमति दी जाए.

(ख) सभी चिकित्सीय रूप से अशक्त कर्मचारियों एवं ऐसे कर्मचारियों के विवाहिता जो कार्य के दौरान मारे गए हैं, को अब से कर्मचारी की अशक्तता/मृत्यु की तारीख से 3 (तीन) महीने की अवधि के भीतर सेवानिवृत्त कर्मचारी उदारीकृत स्वास्थ्य योजना में शामिल होने की अनुमति दी जाएगी.


