Sub:- Medical invalidation of Railway employees on grounds of Psychiatric illness.

Para 556 (2)(vi) provides that Divisional CMS while forwarding the case of medical invalidation to the CMD for constitution of Medical Board would also forward medical record of the employee for the period of 02 yrs of illness. For some time, it has been felt that while the record of 02 yrs might serve the purpose in standard disease, it is not sufficient for Psychiatric cases where no clinical/laboratory exist for diagnosis of such case which is mostly judged by self reported behaviour of the patient. In this background, it has been felt that medical history for a longer period in Psychiatric cases can prove to be useful tool for separating genuine cases from malingering ones. In views of this, it has been decided that medical history of 05 yrs period of the employee to be considered for invalidation cases on the Psychiatric grounds.



Para 556(2) may be substituted as under:-

(2) The CMS/MS in-charge of the division desiring to refer a case to the Chief Medical Director for the examination by a Medical Board, should submit in duplicate, a complete history of the case including investigation reports giving the following details of the Railway employee.

- i. Name.
- ii. Designation.
- iii. Date of appointment.
- iv. Permanent or temporary.
- v. Category to which she/he belongs.
- vi. **Sickness particulars during the last 02 years in standard cases & 05 years in Psychiatric cases.****
- vii. Reasons for holding the Medical Board.
- viii. Two identification marks.
