For transparency, CMDs can evolve a system of empanelling eminent doctors from the locality by putting a news paper advertisement on yearly basis and having the best of three or five with them. They can form a committee of three doctors with MD/CMS/CMO as in charge for screening of the consultant on case to case basis and the committee will record the rationale for making a particular choice. For ultimate cost effectiveness, MD/CMS/CMO should make effort to ascertain that the referral to outside empanelled hospital is kept limited to those cases where it cannot be handled in house even by Consultant on case to case basis scheme.
