**Sub: Family Welfare Programme on All Indian Railways-
Allocation of ADDITIONAL funds for the year 2014-15.**

Ministry of Health & Family Welfare, Government of India, has sanctioned additional fund of Rs. 11,61,300/- (Eleven Lakh Sixty One Thousand and Three Hundred Rupees only) towards compensation for loss of wages to acceptors of sterilization (Tubectomy/Vasectomy) operations and IUD Insertions under Family Welfare Programme on the Indian Railways. Railway wise allotment of this additional fund for the year 2014-15 is given in the enclosed statement.

1. The funds provided by the Ministry of Health & Family Welfare are for the payment of compensation for loss of wages to acceptors of Sterilization (Tubectomy/vasectomy) operation and IUD Insertion.
2. Budget provision for meeting expenditure on 'Compensation' will be available on the basis of actual performance. The outlays agreed for compensation are not divertible for other purposes.


