Sub: The scheme to call Medical Consultants to Railway Hospitals for providing professional services on case to case basis.

Ref: Railway Board's letter No. 2005/H-1/12/34Pt. Dated 05.05.2006 & 2013/H-1/12/4/case to case dated 04.12.2014.

A scheme of calling leading Medical Professional Consultants of the locality, who are willing to come and work in Railway Hospitals, by payment of consultancy fees on case to case basis has been introduced vide Board's letter under reference dated 05.05.2006. Under para 4 of the said letter an upper ceiling limit of expenditure for each zone had been fixed with an overall limit of Rs.2.50 crores/year.

2. The scheme got extended from time to time and the last extension for the year 2014-15 has been issued by Board's letter dated 04.12.2014 with the ceiling limit to the individual zonal Railways/PUs subject to an overall ceiling limit for expenditure fixed at Rs. 4.62 crores.

3. Removal of annual financial ceiling limit of expenditure to the scheme has been examined in Board's office and it has been decided to remove the financial cap to this specific expenditure so long as the overall budget for the concerned hospital/medical department of the division concerned is not exceeded under J-240 allocation i.e. reimbursement of medical expenses.

4. The transparency method of engaging consultants as laid down in Board's letter dated 04.12.2014 may be strictly adhered to.

5. All other terms & conditions will remain the same.

6. This issues with the concurrence of Finance Directorate of Railway Board.
