**Sub: Family Welfare Programme on All Indian Railways- Allocation of funds for  
the year 2016-17.**

Ministry of Health & Family Welfare, Government of India, has sanctioned Rs. 22,77,000/- (Rs. Twenty two lakh Seventy seven thousand) at the disposal of Ministry of Railways for making payments towards compensation for loss of wages to acceptors of sterilization (Tubectomy/Vasectomy) operations and IUD Insertions under Family Welfare Programme. Railway wise allotment of this fund for the year 2016-17 is given in the enclosed statement.

1. The funds provided by the Ministry of Health & Family Welfare are for the payment of compensation for loss of wages to acceptors of Sterilization (Tubectomy/vasectomy) operation and IUD Insertion.
2. Budget provision for meeting expenditure on 'Compensation' will be available on the basis of actual performance and, if necessary, additional funds will be made available to the Railways. The outlays agreed for compensation are not, however, divertible for other purposes.


5. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.


