- 2.3 Cargo related facilities: All activities which will promote the growth of rail cargo e.g. warehouses, storage facilities, grinding, silos, tanks, conveyor belt, decanting facilities etc. and other enabling facilities for cargo like rail/road weigh bridges, truck parking, sorting, grading, packaging, labelling, assembling/disassembling etc. shall be permitted.
