The progress of RSP works regarding Fire & Smoke detection system in AC coaches, Fire detection & suppression system in Power Cars and Pantry Cars has been slow at ZR level.

In this regard, ZRs are advised to expedite the RSP works on priority and target completion in FY 22-23 itself.

Vide letter under reference (i), BG fund outlay for 22-23 has been provided to ZRs for Bulk Order RSP works.

WR and ECoR have intimated that adequate funds are not available against the Fire Safety RSP works and submitted their fund vide letters under reference (ii) & (iii). Other ZRs are also advised to review their fund requirement for Fire Safety works and submit to this office so that re-appropriation proposal can be moved at Board level.

Fund requirement for RSP M(C) works other than Fire Safety works will be sought from ZRs at next Budgetary Stage, i.e. RE Stage.
