In order to optimize the utilization of NMG, NMGH, NMGHS rakes, revised maintenance pattern have been issued in consultation with Traffic Directorate vide letter under reference.

However, from the analysis of data of NMG/NMGH/NMGHS for which BPCs have been issued over CMMS for the period of 01.08.22 to 07.08.22, it is observed that nearly 11% POH overdue and 23% IOH overdue NMG/NMGH/NMGHS coaches have been permitted. Zonal Railways wise details are enclosed as Annexure I and II.

In this regard, it is advised to instruct all the concerned officers to ensure compliance of maintenance regime issued vide reference above strictly.

It is also observed that the nominated workshops/depots are also lagging behind in achieving the allotted target of POH/IOH schedules for NMG/NMGH/NMGHS automobile Cars.

In this regard Zonal Railways are advised to submit the action plan to achieve the target for POH/IOH schedules of NMG/NMGH/NMGHS and cur in date for conversion of POH overdue NMGs into NMGH/NMGHS as per extant policy within workshops.
