

The instruction for twinning of CC examination depots for BTPN, BCNHL & BOXNHL has been issued on trial basis upto 31<sup>st</sup> March 2024 vide Railway Board letters under reference (i). Requests for rationalisation of examination depots were received from Zonal Railways & Traffic Directorate and further deliberated in Railway Board.

Accordingly, it has been decided to revise the twinning/grouping of examination depots for examination of BTPN, BCNHL and BOXNHL rakes as below, for a period up to **31<sup>st</sup> March 2024**, on trial basis:
