Sub: RSP works regarding up gradation of ICF rakes under P B No. 612/24-25 (Suppl/2-18-19).

Ref: i. Railway Board letter no. 2020/M(C)/137/10 dated 06.05.2022.

ii. Railway Board letter no. 2006/M(C)/141/25 dated 10.06.2024.

In view of requirement of running ICF trains for festival specials and upcoming Kumbh Mela 2025, instructions have been issued vide letter under reference (ii) above with the approval of **Board** (MTRS) to keep ICF coaches upto age of 25 years in readiness for use as per operational requirements duly considering all safety aspects in the coaches and attending due IOH/POH.

Accordingly, in view of enhanced requirement of running ICF special trains for upcoming festivals and Kumbh Mela 2025, the required upgradation work of ICF rakes may be executed under P. B No. 612/24-25 (Suppl/2-18-19), in following coaches:

- a. ICF coaches upto age profile of 20 years only, which are not likely to be condemned prematurely due to heavy corrosion.
- b. ICF coaches beyond the age of 20 years undergoing POH for utilization for operation in passenger services.

Subject RSP distribution to ZRs is enclosed as **Annexure**.

Further, PCMEs/Zonal Railways are entrusted to decide on the modalities and scope of work for upgradation in ICF rakes duly considering the passenger amenities and safety requirements etc. Also, it should be ensured that this upgradation work to be executed keeping in view the timelines of Kumbh Mela etc.

The above is issued with the approval of competent authority.
