Vide letter under reference (i) above, the list of additional items/modifications to be included in list of NTXR rejectable items has been issued to Zonal Railways.

Vide letters under reference (ii) and (iii) above, instructions regarding the modification in Lavatory washbasin drain outlet pipe laying for waste water and up-gradation of fire suppression system in Power and Pantry cars from Manual to Automatic System has been issued.

Considering the importance of the modifications, above items has been made NTXR rejectable item in continuation to Railway Bard letter issued vide reference (i) above.

In view of the above following actions may be taken:

- A. All Zonal Railways to ensure that modifications to "Lavatory wash basin drain outlet pipe laying for waste water as per ICF CAI no. ICF/QMS/MDM/File/F015", and "Upgradation of fire suppression system from Manual to Automatic System in Power and Pantry cars as per RDSO specification RDSO/2013/CG-06 (Rev-02) or latest" are completed in Coaching Depots and Workshops.
- B. The proforma for NTXR rejectable defects issued vide letter under reference (i) may be modified accordingly for necessary action by workshops & NCO, making the modifications a rejectable defect as per cut-in date below:
 - a. Lavatory wash basin drain outlet pipe laying for waste water as per ICF CAI no. ICF/QMS/MDM/File/F015 w.e.f 01/10/2024
 - Upgradation of fire suppression system from Manual to Automatic System in Power and Pantry cars as per RDSO specification RDSO/2013/CG-06 (Rev-02) or latest – w.e.f 01/11/2024
- C. Further, all PUs may be advised to ensure that fitment of modified drain outlet pipe to Lavatory wash basin for waste water is carried out as per standardized arrangement issued by ICF with immediate effect.
