Instructions for trial regarding twinning of CC examination depots for examination of Container rakes was issued vide letters under reference (i) & (ii). The trial has been further extended upto 30, September 2024 vide letter under reference (iii).

In this regard, Zonal Railways have sought clarification about grouping of twinned depots having been shown as a consolidated group in reference (iii) instead of pairs of twinned depots shown in reference (i) & (ii).

In response to these queries, it is clarified that S. No. 7 of the table in the letter referenced (iii) should be read as follows:

Instruction for twinning of CC examination depots for BTPN, BCNHL & BOXNHL wagons on trial basis have been issued upto 31st March 2024, vide Railway Board's letters under reference (i). Requests for rationalisation of examination depots were received from Zonal Railways & Traffic Directorate and further deliberated in Railway Board.

Accordingly, it has been decided to extend the trial of the twinning/grouping of examination depots for examination of BCNHL, BOXN/BOXNHL, BOBRN, BOBYN, BTPGLN, BTPN and Container rakes as below, for a further period up to 30th September, 2024.

- 1.0 The matter of rationalization of examination bases of BTPN/BTPGLN, Container, and BOBYN Rakes rakes has been requested by TT Dte./RB and ER adopt twinning for CC rake depots.
- 2.0 Accordingly, it has been decided to do twinning/grouping of BTPN/BTPGLN, Container (BLC) and BOBYN Rakes as detailed below, for a period upto **31**st **March 2024**, on trial basis:

SUB: Rationalisation of CC examination system of container rakes: Twinning of depots on trial basis

REF: TT Dte./RB's Note no. 2009/TT-III/73/8 dated 04.01.2023

- 1.0 The matter of rationalization of examination bases of container rakes has been raised by CTOs and TT Dte./RB vide note u/r has requested to adopt twinning for CC rake depots for Container Stocks.
- 2.0 Accordingly, it has been decided for twinning of container rakes of (i) TKD, DER & DDL and (ii) VZP (CCJS), CKYR(SBI), CTKR(Kolkata) is proposed to be done on trial basis for a period of six months, in first phase, subject to the following conditions:
 - a. Integration of FOIS and FMM has already been started. Its full utilization should be ensured and all rakes to be offered through FOIS for examination and BPC of examined rakes returned back through FOIS.
 - b. Module of enroute detach ment/detention has also been made functional. This should also be made full use of. Timely offering of CC rakes for examination shall be ensured by CFTMs.
 - c. While the rakes would continue to maintain their base identity, they would be offered at any of the depots in the group interchangeably subject to the condition that the no. of examinations do not exceed the daily capacity of the respective depots. This would be monitored by CFTMs through liaison with CRSEs. The delay in examination due to offering a rake beyond the depot's capacity would not be logged on account of wagon maintenance/ C&W.
 - d. The rake once started from nominated base depot will continue to be identified on FOIS and FMM by a rake ID of that base depot only, in spite of the fact that BPC might get issued by other depots. So the rake will continue to be based at its nominated depot only and examination and issue of BPC will take place at the other depots whenever
 - e. Prescribed / needed without changing the ownership of the nominated base depot.
 - f. Number of times during Six Month period that a rake can go to other grouped depots for examination should be limited to two.
 - g. Other instruction for CC examination shall be followed, as issued by Board from time to time.

- h. Once the system of operation under grouping of CC depots starts, all the depots mentioned in the groups will be required to maintain the following information:
 - (i) The cases of loss of traceability for each rake on FOIS/FMM whenever it happens
 - (ii) The cases of all unusual reported by all railways during the run of the rakes and detailed reports.
 - (iii) The cases of asset failures that happen on the rake based at the group depots
 - (iv) The details of each rake examined and cases of overdue running of rakes
 - (v) Monitoring of unloadable wagons in the rakes during run
- Close monitoring of this trial should be done and interim reports to be submitted by the ZRs (PCOMs & PCMEs) on quarterly basis and final report by 14.08.2023.
