1. Southern Railway have entered into Annual Maintenance Contract for maintenance: of Axle Mounted Disc Brake System of LHB type coaches initially for one year for 14 coaches though the case was processed for three years AMC by Mechanical Department, Finance has concurred only for a year and made observations that clear directives from Railway Board to be obtained,

In this connection, Railway Board was advised vide this office letter of even No. dated 15.05.2015 seeking directives with Finance Directorate approval for entering into AMC for Axle mounted Disc brake system of LHB Coaches.

2. A fresh proposal for additional 18 coaches which are due for SS2 was processed and same was concurred by Finance for one year only though the proposal was sent for three years and Finance has observed as under:

"Any#further proposal for AMC:of fresh coaches and for second year in respect of coaches already under AMC cannot be entertained unless Railway Board Issue directives with the concurrence of finance directorate for entering in to AMC."

3. As on date holding of LHB coaches is 217 nos and these coaches are to be brought. under AMC for oxic mounted disc brake system after the expiry of warranty period. Hence, Board is requested to issue necessary directives at the egoligist.
