Sub- COVID-19 (2nd wave) preparedness maintenance schedule of coaches.

Due to the ongoing pandemic COVID-19, train operations were cancelled during lock down periods and accordingly to avoid accumulation of IOH/POH/SS-I/SS-II schedules a detailed guidelines were issued vide Railway Board letter under reference (ii) above. However, these guidelines were applicable up to 31.03.2021 only.

Further, in view of 2nd wave of COVID-19, references from Zonal Railways have been received to extend these guidelines.

Accordingly, Zonal Railways are advised to follow the following instructions while maintenance of Rolling stock:

- 1. The tolerance of POH/IOH/SS-I/SS-II for ICF/LHB coach may be kept as 30+/0-days as similar to the earlier prescribed.
- 2. POH/IOH/SS-I/SS-II schedule for ICF/LHB coaches may be extended by the period of lockdown/idle or by 6 months, whichever is less and accordingly the next immediate IOH/POH/SS-II/SS-I schedule will get extended, only after the under gear examination by lifting the coach in sick line with attention as per A/B/D-II/D-III schedule, ensuring specific examination and accordingly attentions over its trolley, wheel treads and webs and corrosion in under frame.
- 3. Further specific examination shall also be given to the axle box bearing of the coach for grease oozing and other visual defects.
- 4. Any coach not having overhauled as per schedule due, shall, apart from other inspections, be also checked thoroughly for the condition of any perished rubber components, sealants etc.
- 5. Further, the coaches/rakes working in regular train services during this period should not be given extension as prescribed above.

6. While extending POH/SS-II/SS-III as per Para 2 above, it should be ensured that a minimum of 40% of total eligible coaches due for POH/SS-II/SS-III are given

7. While extending schedule as per Para 2 above, it should further be ensured that extension is granted only once in the POH/SS-II cycle.

8. Regular attention as per A/B/D1/D2/D3 schedule for running ICF/LHB coaches 9. The coaches taken under such schedule extension activities should not be

accounted as ineffective stock under maintenance.

10. The UST examination of coaches to be as per RDSO guidelines issued vide

The above instructions will remain in vogue up to till 30th Sept 2021 only.
