Once the train commences its journey, under gear and air brake system examination at pit line may be done on reaching the first destination mentioned in the BPC, irrespective of the distance travelled or time taken for this journey.</li> <li>iii. The BPC will indicate the first destination and at the first destination, if such a train is to re-originate without fresh examination, the Station Master will endorse the next destination on the BPC available with the Guard and Driver, provided the total distance / time limit from the point of last under gear examination till the final destination is not going to exceed the prescribed limit.</li> </ul>
