Sub: Distribution of RSP work of Retro fitment of berths & seats with PU foam as cushion material as per FST properties conforming to EN 45545 part-2 HL-3 with fire barrier cloth compliant to the EN-45545, HL-3 in 5,000 LHB coaches @ Rs.11.75 lakh. (Pink Book Item No-1354/20-21).

In view of various complaints related to seats and berths of Railway Coaches and various technical up gradations done in respect of materials of seats and berths to ensure latest comforts standards and international fire safety standards, it has been decided provide PU foam as cushion material as per FST properties confirming to EN 45545 part-2 HL-3 with fire barrier cloth compliant to the EN-45545, HL-3 and complying to the physical and performance related properties and accordingly to the specification as of MCF RBL.

Subsequently a RSP provisions has also been sanctioned for 5000 Nos, of LHB coaches as mentioned above.
