Context:

A meeting was held to review the issues raised by IRCTC. The discussions and points of action are summarized below.

No	i. IRCTC has requested for conversion of 69 trains from ICF stock having pantry cars to LHB. Out of these, 29 trains (61	PED/Coaching ED/Coaching
	rakes) are required to be converted on priority. ii. It was discussed that Traffic (coaching) may study the requirement and plan for conversion of these rakes. Meanwhile, ICF Pantry cars already converted to flameless Pantry cars may also be inducted in existing ICF rakes and requirement of additional Pantry cars to be modified may also be worked out by Traffic (coaching) and advised for further sanctions.	
2.	Allotment of rakes for Bharat Gaurav along with provision of 3 western toilets in each coach: i. IRCTC requested for 3 Western Style toilets and 1 Indian Style toilet in new coaches being allotted from PUs for Bharat Gaurav Trains in view of the fact that majority of passengers are senior citizens. 	ii. It was discussed that the same may be agreed for AC 3 tier, AC 2 tier and Non-AC sleeper coaches and PUs may be advised accordingly for all BGT rakes to be turned out from PUs. Other modifications in coaches and Pantry car as required by IRCTC may be worked out by IRCTC in consultation with PUs as per the Bharat Gaurav Policy.
