Kindly connect this office's letters cited above on the subject matter and discussions held during PCME's Conference at New Delhi in August 2023.

Based on the information available, it is understood that almost all of 1125 Portable RFID Readers have been distributed by CRIS to various ZRs. This is in addition to 60 Portable RFID Readers distributed earlier to ZRs and coaching PUs. Further, CRIS has been organizing trainings of staff for reading and writing the RFID tags installed on rolling stock using these portable RFID readers.

Data being recorded/encoded/re-encoded through these portable RFID readers will be used by various already-installed/up-coming wayside inspection devices for vehicle identification and will be integrated with various other existing applications.

In view of the above, it is requested that Wagon Workshops, ROH Depots and Sick lines be directed to make extensive use of these Portable RFID Readers and aggressively pursue the tag reading/writing/re-encoding exercise for wagons using the 11 digit numbering system.

Monitoring of Rolling Stock through RFID and other digital devices is a futuristic project. This project has achieved following milestones:-

- 1. 1,93,900 wagons have been fitted with RFID.
- 2. 21,780 coaches have been fitted with RFID.
- 3. 1,121 handheld devices (Portable RFID Readers) have been distributed to ZR's as per allotment done by Railway Board vide reference (ii).

For seamless adoption and operation of RFID technology, the training sessions at various locations over Indian Railways have been organized by CRIS for tag reading, data writing on tags, and practical on-hand training with wagons and coaches under reference (iii).

It is appreciated that all Zonal Railways Have enthusiastically participated in the above training programme.

As the next stage of technological upgradation, ZR's should encourage regular use of these RFID Readers to capture the data of Rolling Stocks.
